2007 Cooled Semen Service Contract

I hereby agree that I will breed my mare, _____, registration number _____, to the stallion _____, owned by Lucky T Ranch, for the 2007 breeding season, which begins February 15 and ends August 30, 2007, subject to the following terms!

1. The stallion breed fee is \$500.00 including a non-refundable 30% booking fee. The chute fee is \$250.00. The chute fee includes collection and shipping. The chute fee will be charged with each additional shipment of semen and must be paid prior to shipment.
2. This contract contains a "LFG" Live Foal Guarantee. A live foal is described as a newborn foal, which stands and nurses unassisted. If the foal is born dead, or fails to stand and nurse, return privileges shall apply, only if Lucky T Ranch is notified within seven (7) days thereof and receives a veterinarian's statement confirming death. The "LFG" in this contract is non-transferable and should the mare be sold or otherwise disposed of prior to the birth of foal, the live foal guarantee granted, shall be void. Return privileges shall apply only to the next normal breeding season.
3. If the mare miscarries, proves barren after being pregnancy checked in foal, or fails to conceive during the normal breeding season, Lucky T Ranch agrees to breed said mare again during the immediately following year's breeding season. There will be a charge of \$300.00 for the "re-breed" service expenses (chute fee/handling fee). Should the original mare be deemed unfit for breeding, a substitute mare may be accepted at the discretion of Lucky T Ranch.

We recommend prior to the first shipment of semen, mare owner, have a licensed veterinarian check said mare and she have a clean culture and is current on all her inoculations (within the last 3 months). Mare owner is also responsible for having said mare examined for pregnancy by ultrasound at 18-21 days after last breeding. We recommend another rectal examination or ultrasound at 45 days, to insure pregnancy.

4. A "Breeders Certificate" will be issued for the foal conceived when stallion fees, and all other expenses have been paid, and when Lucky T Ranch is notified that a Live Foal has been produced.

5. Lucky T Ranch further agrees that should the stallion die or become unfit for service the "Mare Owner" has the option to choose another of Lucky T Ranch's standing stallions, or that this contract becomes null and void. Any monies paid by the mare owner toward the stallion fee, with the exception of the non-refundable booking fee, shall be refunded to the mare owner.

6. This contract shall be binding upon the parties hereto, upon execution hereof and the same may not be altered or amended, except by the written mutual consent of the parties hereto.
